1. 10% The reputation of the proposer and of the proposers goods or services.
2. 10% The quality of the proposers goods or services.
3. 10% The impact on the relationship with EnviroTech/Parkmay and the district.
4. 10% The extent to which the goods or services meet the district's needs.
5. 30% The purchase price.
6. 10% The total long-term cost to the district to acquire the proposers goods or services.
7. 10% The impact on the ability of the district to comply with laws, rules, and goals relating to historically underutilized businesses.
8. 10% Any other relevant factor that a private business entity would consider in selecting a vendor.

Envirotech/Parkmay and B.I.S.D., reserves the right to reject any or all proposals and to waive any formalities in the proposal process. No proposal shall be withdrawn within a period of 90 days subsequent to the opening of the proposals without the written consent of Envirotech/Parkmay.

INSTRUCTIONS TO PROPOSERS FOR THE BEAUMONT INDEPENDENT SCHOOL DISTRICT FRENCH ELEMENTARY SCHOOL

1. INTERPRETATION OF THE CONSTRUCTION DOCUMENTS:

- A. The Construction Documents for this project have been prepared for use by Envirotech/Parkmay in securing proposals from material suppliers, as well as Envirotech/Parkmay own use in preparing a bid proposal to B. I. S.D., for the work. They are also to be used for construction purposes.

- C. Should any Contractor find discrepancies in the Construction Documents or should he be in doubt as to their exact meaning, they must notify the Envirotech/Parkmay. The Architect may then, at his option, issue Addenda clarifying same. Envirotech/Parkmay and the HKA Architects will not be responsible for oral instructions or for misinterpretations of the Construction Documents.
- D. The Architect reserves the right to issue Addenda at any time prior to bid opening. All reasonable efforts will be made to issue any Addenda as early as possible. All such Addenda become, upon issuance, an inseparable part of the construction documents. Each Contractor shall cover such Addenda in their bid and acknowledge receipt of same.
- E. Each Contractor shall be held to have studied the Construction Documents, to have visited the site, to have satisfied themselves regarding all existing conditions and measurements, and to have included in their Bid an amount sufficient to cover all work.
- F. In the event a conflict should occur between Contract Documents, which would alter the contract amount, it will be assumed that the most expensive method, material, or process had been included in the contractor's proposal.
